Introduction

The Certified Staff Survey is for all Certified employees who work for the Beaverton School District, either part-time or full-time. It is not for volunteers or contractors. Survey reports from previous years can be viewed on the <u>BSD Research and Reports Page</u>.

This survey is voluntary. You may opt out of completing the survey at any time, without penalty. Survey data will be summarized so that answers will remain anonymous. Nothing in the survey content or District software will be used to identify you. Your email is not connected to the survey.

When you select "Done," you will be redirected to the 2023 BSD Climate Survey for all staff. The Climate Survey has three sets of questions and includes optional demographic questions. The two surveys are completely separate and your responses to the surveys cannot be connected. We hope this separation will help you feel more comfortable responding honestly.
