							At the beginning of the boundary process the District provided 4 objectives for the Middle School Attendance Boundary Adjustment and guidance on how the committee should focus their recommendations. 1. Create an attendance boundary for the Timberland area middle school that provides a projected student population sufficient for comprehensive middle school programming. (No change to Highland Park is needed to meet this objective)2. Adjust the attendance boundary for Stoller MS to provide a projected student population of approximately 90% of the permanent capacity of Stoller MS. (No change to Highland Park is needed to meet this objective)3. Review and adjust the attendance boundaries of other middle schools, as needed, to accommodate the new Timberland-area middle school boundary. (No change to Highland Park is needed to meet this objective)4. I worry that so much mental energy was spent on Springville and Stoller that the committee may be making final decisions for the southern schools without all of the info and without a true understanding of what makes our neighborhoods and communities unique. Terra Linda brings several important elements to Timberland and Terra Linda belongs at Timberland. We are the poorest school north of 26 (by a significant amount). We are one of the oldest neighborhoods north of 26 and we have been bussed far away to middle school for a long time. We have one of the larger, if not largest, Hispanic populations north of 26. We are the smallest school north of 26. The timberland boundary had strong support at the start of the last meeting and the Timberland boundary should stay as it is. Timberland has the right number of students, the right feeder pattern, a continuous boundary area, the closest neighborhoods are in attendance. Timberland is not the richest school in the district but it is close. Terra Linda provides the only real source of economic diversity to Timberland and Terra Linda needs to stay in the Timberland boundary to provide diversity, appropriate utilization of capacity, racial diversity, and community.
