Safe Routes to School (SRTs) is a national and international movement to promote safer, more convenient, and healthier alternatives to walking or cycling to school. The Center for a Healthy Community (RADY) for Children has completed a three-year STR program at an elementary school in Southeast San Diego. The focus on pedestrian safety led to a drastic reduction in accidents in the SRT zone. One of the goals for the school board is to create healthy communities by providing safe walking and cycling routes that educate and encourage students and to increase the number of children walking or cycling to school by funding projects that eliminate barriers to walking such as poor streets, limited adult supervision, and crime. Without limited adult supervision, it is not currently possible for kids to walk to school on already crowded Springville road. During summer 2021, it was also evident that the crowded Springville area caused the demise of a young soul new Springville school. Young traveling children often rely on adults to drive them or other means of transport such as transit and carpooling, resulting in more traffic around the Springville area. Safe routes to school should be the priority of the students. 2) We moved to the Crossvine area recently with the assumption that school boundaries are already fixed, and Sato Elementary school was one of the main reasons which led to our decision.3) There are around 20 houses after the crossvine area and it should not be a big concern for the school board due to the number of students(10 to 15 kids).
